

SAFEGUARDING NEWS – February 2018

WELCOME to the fifth issue of the newsletter which brings the latest news from the Safeguarding Team to all churches in the Diocese of St Albans.

Introduction by Bishop Alan

I would like to take this opportunity to thank you for your hard work in 2017 in promoting the welfare of the vulnerable and helping to keep them safe.

The safeguarding of children and vulnerable adults is an absolute priority in our diocese. In 2017 the safeguarding audit showed that this diocese deals with safeguarding effectively and recognised that we are determined to work together to make our churches and chaplaincies safer places. We are committed to ensuring that anyone who has suffered abuse is properly heard, properly cared for and is entitled to justice. We cannot do this alone. It is the responsibility of everyone to create a culture in which abuse simply will not happen, by showing the care and the responsibility that is our duty as members of the communities in which we live and work. Evidence shows that a strong community is a significant factor in preventing harm. Abuse of any kind is contrary to the will of God, and is an affront to human dignity. We must all work together to ensure our churches, our chaplaincies and our communities are as safe as they can possibly be.



Safeguarding Audit

In September 2017, St Albans Diocese were subject to a national independent safeguarding audit, commissioned by the national Church of England. The resulting report was positive but will not lead to complacency. The appointment of an Assistant DSA will provide scope to build on this good work as well as respond more effectively to increasing ongoing demands.
