Membership

The Bishop of St Albans

Five persons nominated by the Bishop, at least one of whom must be an Archdeacon within the Diocese and all of whom have experience of other areas of work with which the Board is concerned.

Elected Members

Seven members (who need not be members of Diocesan Synod but must worship, work or live in the Diocese) nominated by deanery synods and elected by members of the Diocesan Synod, according to the rules stated below:

- a) three Headteachers from schools within the Diocese of whom two shall be from a Primary School and one shall be from a Secondary School and who may be lay members or Clerks in Holy Orders.
- b) two lay members; and
- c) two Clerks in Holy Orders beneficed or licensed in the Diocese.
